## COVENANTS, CONDITIONS, RESTRICTIONS, AND EASEMENTS

## REMINGTON PLACE HOMEOWNERS ASSOCIATION

THIS supplemental declaration of covenants and restrictions made this 19th day of September

2014, by REMINGTON PLACE HOMEOWNERS ASSOCIATION, an Oklahoma corporation (the declarant)

## WITNESSETH:

Recitations, on or about February 5<sup>th</sup>, 2004, Remington Renovations, Inc. executed a Declaration of Covenants, Conditions, and Easements, and a Declaration of Covenants, Conditions and by-laws for Remington Place Estates I (the Declaration). The Declaration was filed on February 6<sup>th</sup> 2004, Book 1691 at page 184 and in Book 1691 at Page 193, respectively, in the office of the County Clerk of McClain County, Oklahoma.

The Declarant further extended the scheme of the covenants, voting rights and restrictions contained in the Declaration to the Additional Property, and to provide that all persons owning lots within Remington Place Estates II and Remington Place Estates III, shall be Members of the Remington Place Homeowners Association, the Association established in accordance with the original Declaration and the lots within Remington Place Estates II and Remington Place Estates III , shall be subject to the terms and 133

Supplementary Declaration. Declarant hereby declares that a meeting of its General Membership, a majority present to constitute a quorum, on September 13th 2011 voted to amend its covenants as follows.

#1. Amend Section 2.25 book: 1691 page 189 to the following Our neighborhood will be following the City of Newcastle Ordinance 116.09

- The discharge of fireworks, except at a display permitted herein, is prohibited at all times and places except between the hours of 8:00 a.m. and midnight on the dates authorized by the Newcastle City Council if those dates are other than July 2, 3, 4 and 5 of any given year. It shall be unlawful for any person to discharge fireworks from any public street, right of way or
- The discharge of fireworks upon private property shall be unlawful unless the owner or tenant thereof is present or the persons discharging the fireworks have written permission from an owner or tenant thereof.

Effective Date: From and after the date of filing this Supplemental Declaration of Covenants and Restrictions in the office of the county Clerk of McClain County, Oklahoma, the covenant shall be in effect.
